Another Cohort Completes ACUE Certification

The third cohort of Broward College faculty, staff, and administrators have completed the Association of College and University Educators (ACUE) certificate program in Effective Teaching Practices. The 2019-20 ACUE Cohort consisted of 66 full-time and part-time faculty and administrators who teach. The group started the training in September 2019 and completed it in April 2020. They were recognized at two virtual pinning ceremonies on Friday, October 9, and Friday, October 16. Broward College has a five-year partnership with ACUE to license 500 faculty to improve classroom teaching and student success. The intensive program, which is offered over two terms, is fully-online and nationally accredited. The program has already shown tremendous success in achieving equity among students. A 2020 study by ACUE found that students at Broward College were more likely to complete and pass their courses when taught by ACUE-credentialed faculty. The impact was significantly higher on achievement outcomes for Black and low-income students.



Osprey Awards Goes Virtual to Recognize Employees

It was a virtual red carpet event on Friday, November 13, as the College hosted a special edition of the Osprey Awards. The Ospreys is the College's rebranded employee recognition ceremony. The annual event celebrates employee achievements and milestones across various categories. Among them 10, 15, 20, 25, 30, and 35 years of service; innovative teaching; professors of the year; years of giving; unsung heroes, including those who continue to work on campus during the pandemic; and a creative achievement award. More than 300 employees were recognized. This year's Osprey Awards, organized by the Center for Teaching Excellence and Learning (CTEL) and Institutional Events, brought an innovative spin on an all-time favorite, taking guests over the rainbow into the Land of 'Ozprey' (Broward College). The ceremony was hosted by Dr. Julia Philyaw, associate vice president, CTEL and Ellice Martinez, associate vice president, Community Partnerships and Institutional Events.

FPL Supports Broward College and Other Regional Institutions with Laptop Donation

Florida Power & Light Company (FPL) has donated more than \$1 million to be divided among four colleges to buy laptops for students enrolled in Rapid Credential programs. Broward College will use its portion to buy 400 laptops. Rapid Credentials offer short-term technical certificates and industry certifications that can be earned in less than a year. These programs have been highlighted as part of Governor Ron DeSantis' 'Get There' initiative announced in September and are geared toward Floridians whose employment has been impacted by the pandemic. The donation of the laptops is part of a larger FPL technology pilot program involving partnerships with Palm Beach State College, Miami Dade College and The State College of Florida, Manatee-Sarasota, in addition to Broward College. In total, the \$1 million donation from FPL will buy more than 1,600 laptops.

Broward College Nursing Program Earns Re-Accreditation

Broward College's Bachelor of Science in Nursing (RB-BSN) Program has earned re-accreditation from the Commission on Collegiate Nursing Education (CCNE) Board of Commissioners for the maximum time of ten years, extending to December 30, 2030. The CCNE Board determined that Broward College's program met all four accreditation standards and no compliance concerns concerning the key elements.

The RN-BSN Program is designed to prepare individuals for a career as a registered nurse. The goals of the RN-BSN Program build on the mission of the College's Associate of Science in Nursing. Applicants to the RN-BSN Program must possess an associate degree or higher from an accredited institution recognized by Broward College. They must also hold an unrestricted and unencumbered active license as a registered nurse in Florida.

Billy Jones Announced as President-Elect of Faculty Senate

Dr. Billy Jones, assistant professor, English, has been elected as faculty senate president for 2021. Dr. Jones will assume the role on January 5. He takes over from Dr. Andrea Apa, assistant professor, ESL and Reading, who served as president since 2018. Dr. Apa, who will be on sabbatical, has been instrumental in coordinating faculty engagement in many priority efforts, including shared governance and Broward UP^{TM} . In welcoming the announcement, President Haile said, "Both Drs. Jones and Apa embody the passion and commitment of the College's faculty, who are essential in their various roles inside and outside the classroom. We look forward to our continued partnership with the Faculty Senate as together, we serve to uplift our community and support student success."


SHEILA WEBSTER, RECORDS ADMINISTRATION

Second Virtual Commencement Scheduled for Fall

Broward College will host its second virtual commencement on Saturday, December 19 at 1 p.m. to celebrate more than 5,000 students who are eligible for graduation, earning associate degrees, bachelor's degrees, and certificates. Team Broward College Participates in Uptown VK

The Aviation Institute and Broward UP partnered this year to sponsor the Uptown 5K on the Runway, benefiting the Trustbridge Hospice Foundation. The race was initially scheduled for April 18 but was postponed due to the pandemic. Realizing that large, inperson events probably wouldn't be realistic for a while, organizers transitioned the event to the Uptown VK, a 200-mile virtual relay race, with teams completing the distance between Fort Lauderdale Executive Airport and Key West International Airport. Each team member logs their miles on the event website. The Uptown VK runs from Saturday, November 14 to Saturday, December 12, but already the eight-member Broward College team has logged more than 160 miles, virtually placing them in the Keys. Along the way, there are several 'pit stops' of which the Emil Buehler Aviation Institute on the Judson A. Samuels South Campus is the first. The College's sponsorship allows the opportunity to showcase to participants and observers the Aviation Institute and Broward UP through a video. The event has so far reached almost 1,000 people. Thank You for Making Giving Tuesday a Success

The Broward College community rose to the challenge on #GivingTuesday. The Broward College Foundation campaign launched around Giving Tuesday on December 1 was a success thanks to faculty, staff, alumni, parents and friends, and so many others. The first #GivingTuesday campaign in the College's history received 104 contributions and raised more than \$89,000. The enthusiasm to see the College succeed has been inspiring. The College is thankful for everyone who gave, shared, and spread the word about the importance of #BrowardGives on #GivingTuesday.



Update on Enrollment Trends

In her report to the Board, VP Stubbs explained that data from the National Clearing House Resource Center from September to November 2020 shows a continuing decline in community college enrollment, while private colleges and universities saw some modest increases. She explained that freshman enrollment is down across the country, and communities of color reflect the highest decline of around 30 percent, which mirrors the decline the College is seeing in its First Time in College (FTIC) enrollment. She said the College's spring 2021 enrollment strategies include collaborating with various departments to leverage resources to support registration. This consists of the roll-out of Rapid Credentials—short-term training courses available at no cost thanks to funding from the state. VP Stubbs said she expects some positive impact on enrollment based on these courses. As part of the enrollment drive, the College is also promoting scholarship opportunities, transfer agreements, specific in-demand programs, several marketing campaigns, and hosting webinars and virtual open houses. She encouraged everyone to share their Broward College story with neighbors and friends.

Financial Review to the Board Explains Cost-Saving Measures and Provides Reimbursement Updates

VP Cornelius told the Board revenue is down significantly due to budget adjustments from the state and declining enrollment. He said there had been some mitigating actions by the College, including minimizing expenses where possible, especially in facilities. Currently, he explained, the College realizes operational expense savings of around \$750,000 per month, and this is expected through the end of November. He explained there would be a decline in these savings with the return of more in-person classes on campus in spring. VP Cornelius also told the Board that the College is about \$1.5 million off the planned budget for the year and that higher education could face possible cuts of eight to ten percent in state funding for the next fiscal period.

The Board also received an update on the actions taken under the temporary authority granted to the College's administration to refund tuition and fees. Over the last three terms, the College has reimbursed or removed fees for labs and parking, totaling \$1.9 million, of which \$1.1 million will be covered under the CARES Act funding.

Broward College Foundation to Launch First Major Campaign in 30 Years

The campaign will be the first comprehensive fundraising effort by the Broward College Foundation in the last 30 years. The leadership team is working with BrightDot Consulting, and the Board heard presentations from BrightDot president Dr. Bill Crouch and consultant Michael Straighter. Both presenters reiterated that it was a good time for the College to pursue a campaign, given the increase in giving to nonprofits experienced in 2020. The comprehensive campaign is a five-year effort and will focus on talking to philanthropists about investment. The process began six months ago with an assessment of the Broward College Foundation and coaching of its staff. The next phase of the campaign will include a focus group with community members to assess their perspective. The team will then spend 12 to 18 months developing a campaign structure and identifying leadership, followed by a public announcement and milestone celebrations.



Revisions to General Education Requirements Approved

General Education courses constitute 36 credits of an Associate of Arts degree and 15 in the Associate of Science degree. The revisions to the General Education requirements occur every five years, and the approved changes will take effect in fall 2021. The revisions were developed by a cross-functional task force led by Josh Kimber, associate professor, Philosophy. The Board approved the revision to the general education statement, revised competencies, revised learning outcomes, revised assessment map, revised framework including credit requirements for each general education area, requirements of each area, and additional education options, which is new. The Board also approved the 145 General Education courses recommended by the task force.

The General Education program is an integral part of the learning experience at the College. It provides broad knowledge as well as intellectual and personal development beyond a specific discipline or major. The revised General Education competencies and learning outcomes are focused on critical thinking, effective communication, ethical reasoning, global awareness, information literacy, and mathematical and scientific reasoning. The task force was charged with ensuring that the College's general education competencies are most directly aligned to students' success in the workforce, their career paths, and transfer to universities. The changes will set the College apart from other colleges.

Board Approves Laboratory Fee Modifications for the 2021-2022 Academic Year

The Florida statute grants authority to the Board to establish laboratory fees. These fees are limited to the cost of equipment, maintenance and repair, service contracts, core-specific software, standardized testing, laboratory supplies, and course-specific part-time personnel. To calculate the fees, the College undertakes an analysis that includes a review of paid enrollment for the courses, actual allowable expenditures for the courses, and any revisions to the curriculum. A total of 239 courses were reviewed, and an increase in fees recommended for 19 courses, a decrease in fees for 37 courses, and removal of fees for 44 courses. The remaining 139 courses will not have any changes.

Board Congratulates Dr. Marielena DeSanctis on Being Named President of the Community College of Denver (CCD)

The trustees, led by Chair Gloria Fernandez, congratulated Dr. DeSanctis on her selection as CCD president after a national search. The team thanked her for her service to the institution. Dr. DeSanctis, provost and senior vice president for Academic Affairs and Student Services of Broward College, will leave her current role at Broward College on January 14, 2021, and assume her new role on January 15, 2021. "Dr. DeSanctis has displayed an exceptional will to support our students and a values-based system rooted in student success. She has also proven herself a champion of academic excellence and innovative teaching," said President Haile in offering his congratulations. "Although the Broward College community will miss her, we are excited for her opportunity to positively impact the Denver community. I look forward to supporting her continued success."
