U.S. Secretary of Education Miguel Cardona Recognizes Broward UP as “an Example of What We Need to See Across the Country”

United States Secretary of Education Miguel A. Cardona and Congresswoman Debbie Wasserman Schultz participated in a conversation with Broward College students about the educational opportunities, workforce training, and support services offered through Broward UP on Monday, April 4, at Cypress Bay High School in Weston. Five Broward College students—Voneshia Corbin, Nadine Plunkett, Arnel Polo, Ana Maria Forero, and Isaac Ruiz—discussed with Secretary Cardona and Congresswoman Wasserman Schultz how Broward UP set them on a path toward higher education and greater earning potential. President Haile and Dr. Mildred Coyne, senior vice president, Workforce Innovation, led the presentations. Secretary Cardona in his remarks declared that Broward UP should be a national example. “We have a short window to disrupt the systems that were there before that didn’t work, and that is why Broward UP to me is so important, because it is an example of what we need to see across the country,” he said. “Not only because it provides opportunities for the students that are in it, but it provides economic mobility for the participants and the community. This is community development at its best.”

President Haile expressed gratitude for the federal funding allocated to the College through the U.S. Department of Education grant and the federal budget bill. In September 2021, Broward College became the first entity in Florida and the first community college in the nation to receive the Promise Neighborhoods grant (of \$30 million), which supports the educational and developmental outcomes of youth and helps improve economic mobility in communities. In addition, as part of the Fiscal Year 2022 Federal Budget Bill, Representative Wasserman Schultz secured \$2 million in federal funding to expand workforce training initiatives at Broward College.

The Secretary of Education’s visit was a great way to begin April, which is Community College Month.

Broward College Hosts Representatives from Florida Department of Education for Roundtable Discussion and Visit to the L.A. Lee YMCA/Mizell Community Center

Representatives from the Florida Department of Education (FDOE) joined President Haile and other delegates from Broward College for a roundtable discussion and a tour of the College’s new facilities at the L.A. Lee YMCA/Mizell Community Center in Fort Lauderdale on Thursday, March 31. Senior Chancellor Henry Mack, Statewide Director of Professional Development Rachel Ludwig, and Bureau Chief of Adult Education Dr. Ashley Yopp of the FDOE met with the team to learn about how Broward College continues to uplift its community and improve workforce outcomes through models like Broward UP and the Broward College Entrepreneurial Experience (BCEx), both of which support entrepreneurial education and training.

The new Broward College location at L.A. Lee YMCA/Mizell Community Center will offer courses and free certificates to students and community members, focusing on improving access and connecting residents to better earning potential while meeting our workforce needs. Residents can earn free certificates in Lean Six Sigma, Supply Chain Management, and Customer Service Operations with no diploma or other degree required. The College received \$1 million in funding over the next four years to support its lease of the fourth floor of the YMCA facility.

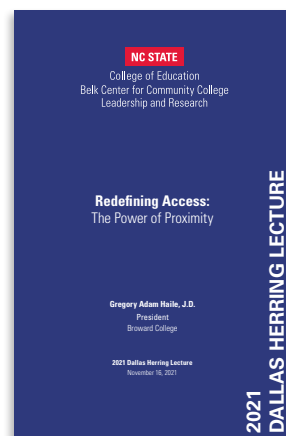

The Broward College Village Square hosted its second dinner of the season and the first in-person event since the pandemic on Wednesday, February 27, at the Funky Buddha in Oakland Park. The debate focused on the difference between media, news and information. More than 60 people filled the room to hear panelists discuss themes related to bias in the behavior of news reporters, the influence of social media, and the effect of marketing on journalistic discourse. The event featured Evelyn Baker, executive producer, Univision Communications, Inc. and adjunct professor at Broward College; Frank J. Guzman, Broward bureau chief at WSVN-TV; and Justin Sayfie, publisher at Sayfie Review and Partner at Ballard Partners. It was moderated by Ann Marie Sorrell, president and CEO at The Mosaic Group. The next Village Square Dinner at the Square event will take place on Wednesday, April 27, at the Funky Buddha in Oakland Park. The theme of the discussion will be “Competition Is Good for Customers, but Would it Benefit Schools?”

Broward College Partners with Deerfield Beach to Provide Workforce Education and Training Through Broward UP

The City of Deerfield Beach is the latest municipality to partner with the College to provide free educational opportunities, workforce training, and support services to residents. The partnership was made official at the City Commission meeting on Thursday, March 15. The City Commission voted unanimously to provide access to Broward UP to eligible residents. Broward UP was initially launched in 2018 in six zip codes with high unemployment and low post-secondary attainment. Broward UP's expansion to Deerfield Beach zip codes 33441 and 33064 and other zip codes is possible thanks to a \$30 million gift from philanthropist Mackenzie Scott and her husband Dan Jewett, allowing the College to expand its service model.



Broward College Awarded Two TRIO Talent Search Grants to Help Low-Income First-Generation College Students Access Higher Education

The College received two TRIO Talent Search grants totaling almost \$3 million from the U.S. Department of Education to help more prospective first-generation college students pursue higher education. In its first-ever Talent Search grants, Broward College and its collaborative partner, Broward County Public Schools (BCPS), will conduct two projects: Project ASPIRE, which will serve Boyd H. Anderson High School, Northeast High School, Sun Fire High School, Lauderdale Lakes Middle, and Lauderhill 6-8; and Project REACH, which will serve Dillard High School, Plantation High School, Sunrise High School, and Parkway Middle School. Students will receive counseling and have access to college and financial application assistance, college entrance test preparation, and career exploration to better understand their educational options. Both projects will also conduct online project-based STEM learning activities, connect students to tutoring and other services, and promote dual enrollment and industry-recognized certification training in Broward UP communities.

President Haile Named Finalist for AACC CEO of the Year Award

President Haile has been named among six finalists for the inaugural American Association of Community Colleges' 2022 CEO of the Year Award. Winners will be announced at the Awards of Excellence Gala on Monday, May 2, during the AACC Annual Conference held in New York City, April 30 to May 3.

President Haile will also present alongside Josh Wyner, executive director of the College Excellence Program at the Aspen Institute, in a session on Equity in Career and Technical Education Programs at the AACC Annual Conference on Sunday, May 1. In addition, Drs. Mildred Coyne and Jennifer Saint Louis will present a session titled "Achieving Unlimited Potential – A New Community-Based Education Model," at the AACC Annual Conference. The session will introduce Broward College's innovative post-secondary education model, impact, and growth to a national audience of higher education practitioners interested in replication in their communities.

Faculty and Staff Explore Cultivating Connections for Professional Development Day 2022

More than 900 Faculty and staff engaged remotely for a successful Professional Development Day on Friday, February 18, organized by the Center for Teaching Excellence and Learning (CTEL) and Workplace Learning in Talent and Culture. Under the theme, Cultivating Connections – Building Community, speakers and panelists from various departments and pathways across the College took part in discussions and workshops focused on meeting the need for institution-wide resilience and compassion, encouraging growth and reflection during and post-pandemic. The opening and closing sessions featured Broward College panelists and moderators, including students, while an external presenter facilitated the mid-day session. Dr. Emerald Templeton, an equity-minded scholar-practitioner with expertise in organizational leadership counseling, student affairs, and educational partnerships, focused her mid-day presentation on an asset-based approach to student support. In a post-event survey, participants provided insight from their experiences within their pathways and future goals, which will be considered for future Professional Development discussions and training.



Festival of Music, Film, Literature, and Art Continued to Grow in Virtual Environment

This year's Music, Film, Literature, and Art Festival (MFLA) at Broward College from March 8 to 18 was offered in a hybrid virtual and in-person setting. Centered on the theme, "A Changing World: Envisioning What's Next," the festival reflected the ongoing changes to our day-to-day lives through the arts. The festival garnered more than 1,000 attendees, including guests from creative-interest groups and K-12 school districts from Florida, New York, and California, as well as attendees from La Universidad Iberoamericana (UNIBE), a private non-profit university in Santo Domingo, Dominican Republic. Featured presenters were Marquis McGriff, author of "The Dad I Had;" Anika S. Madison, author and podcaster; and Jarred Amato, founder of Project LIT. The festival also included discussions on wildlife conservation, Blackout Poetry, and opportunities in the film industry. Co-chaired by Associate Professor Dr. Billy Jones and Assistant Professor Regine Darius, MFLA has grown exponentially in just seven years and showcases the work of the faculty and staff and expertise from all eight pathways.

Members of the delegation participated in a seminar with faculty from India, held meetings with local businesses and took part in a community foundation that empowers women. The research trip also included cultural visits in Delhi, Agra, Jaipur, and Kolkata, including the Taj Mahal and The Mother Theresa center.

Celebrating Women's History Month

The College celebrated Women's History Month with an array of events throughout March. This year's festivities recognized "Women Providing Healing, Promoting Hope," focusing on the inspiring work of caregivers and frontline healthcare workers during the COVID-19 pandemic and women who have provided healing and hope throughout history. Several organizations participated in the celebrations. The Institute of Public Safety and Broward College Student Life hosted a Women in Leadership panel titled "Women Leaders Empowering Future Leaders," on Wednesday, March 9. On Thursday, March 17, the South Campus Gallery held an opening for "Collecting Somewhere – Documenting the Changing South Florida Roadside and Honoring Women," by artist Lorna Ruth Galloway. Attendees were encouraged to donate gently used clothing in support of the charitable organization Women in Distress, as well as hygiene products in support of Broward College's Seahawk Outreach Services. Other events were, "A Conversation with Broward College's Armed Forces Leading Ladies" on Monday, March 21; an interactive live museum representing different women's issues and contributions at the North Campus on Tuesday, March 22; a virtual panel discussion on feminist trailblazer bell hooks on Thursday, March 24; and a Women's History Month "Book Tasting" on Thursday, March 31.

\$2 Million in Federal Funding Received for Broward UP

As part of the federal budget bill passed by Congress earlier this month, Broward College will receive \$2 million in funds to support Broward UP and other workforce training programs. The funds were requested by Rep. Debbie Wasserman Schultz, who last June met virtually with the Board of Trustees to discuss opportunities available for new and existing Broward College students that can help them pay for an array of education expenses.

President Haile Championed Health Equity for All at American Heart Association’s 2022 Broward Heart Walk

President Haile and his wife and daughters participated in the American Heart Association South Florida chapter’s Broward Heart Walk fundraiser at Nova Southeastern University (NSU) on Sunday, March 13. The three-mile walk brought in more than \$1 million in donations that will go toward championing health equity for all, training thousands in CPR, and funding heart research throughout the year. President Haile was on-hand to participate in the walk at NSU, but participants were also able to take part remotely by walking three miles at a location of their discretion. Other attendees included NBA All-Star and founder of the Mourning Family Foundation Alonzo Mourning and CITY Furniture CEO Andrew Koenig.

More than 800 Attend an Afternoon with Chris Bosh

Broward College Student Life presented a conversation with two-time NBA Champion Chris Bosh at the A. Hugh Adams Central Campus on Thursday, March 17. The event, titled “An Afternoon with Chris Bosh,” featured the former Miami Heat player and 11-time NBA All-Star sharing his experiences as a professional athlete and discussing the skills necessary to be successful in life and on the court. The afternoon began with a Fireside Chat in the gym with Associate Vice President of Workforce Education Employment Solutions Imran Siddiqui, part of a Broward College Entrepreneurship (BCEx) event designed as an opportunity for founders, students, and staff to hear entrepreneurial insights. In a second event, 825 students from Broward College, Florida Atlantic University (FAU), and other partner institutions including Boys & Girls Club of Broward County, HANDY Inc., Hispanic Unity of Florida, Urban League of Broward County, and Broward County Public Schools gathered at Bailey Hall to hear Bosh’s first-hand stories of grit and determination before and during his NBA career. Sharing excerpts from his book, “Letters to a Young Athlete,” Bosh motivated and inspired students to find their passion and pursue it even if they face uncertainties in their life. His presentation was followed by a Question and Answer session moderated by Senior Director of Student Engagement Carlos Parra. A book signing at FAU Davie Union concluded Bosh’s visit.

BOARD NEWS

Board Receives Overview from Vice Provosts

As part of the Student Forum, each of the College's three interim vice provosts, who also oversee campus operations, provided the board with an overview of their areas and important updates or developments. In his presentation, Dr. Donald Astrab, interim vice provost, Academic Operations, Analytics, and Communication, who is responsible for the Judson A. Samuels South Campus and the Partnership Centers, highlighted that the campus would open a food pantry within the next month. He addressed improvements in food options available to students through food trucks. Dr. Astrab also discussed the relocation of P'an Ku, the College's literary magazine, and the Air Traffic Control program to the campus. The latter was made possible through Higher Education Emergency Relief (HEERF) funding to the College.

Dr. Jamonica Rolle, interim vice provost, Academic Affairs, who oversees the North Campus, provided an overview of her responsibilities. She detailed student enrollment by programs, of which Health Sciences and the Business pathways had the highest enrollment. She also shared details of student engagement activities that have seen a resurgence through Student Life, as well as work in community outreach and partnerships to strengthen the College's connection with the communities it serves.

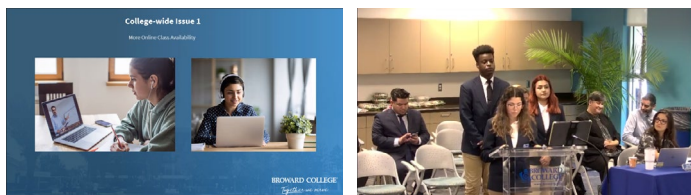
Dr. Stephanie Etter, interim vice provost, Academic Services and Learning Resources, whose purview includes the A. Hugh Adams Central Campus, shared her responsibilities. Her presentation spotlighted the Institute of Public Safety, the Health Sciences Simulation Center, the Rosemary Duffy Larson Gallery, and the work being undertaken through the Transfer Scholars Network, Helios Foundation Scholarship, Dual Enrollment, and the Honors College.

Social Enterprise Plan Update

Renee Law, associate vice president, Institutional Planning and Effectiveness, provided an update to the Board on the status of the College's next strategic plan, the Social Enterprise Plan. The Social Enterprise Plan will replace the existing Strategic Plan, which ends on June 30, 2022. AVP Law reminded the College community of the timelines for establishing strategy and developing tactical approaches, including engagement with the Board of Trustees, students, faculty and staff, and external stakeholders. She explained the main feedback received from each group and the development of strategic priority statements based on common threads found in discussions. She added that the Social Enterprise Plan team is engaging the College community in developing tactical approaches to actualize strategies and prioritize activities for resource allocation during March and April for final approval by the Board of Trustees in June 2022.

Student Forum Takes Center Stage at March Board Meeting

Student Government Association (SGA) leaders for the Judson A. Samuels South Campus and North Campus led the Student Forum presentations to the Board. Gali Polichuk, president, Judson A. Samuels South Campus SGA; Xiomara Campos, vice president, Judson A. Samuels South Campus SGA; and Devonte Caine, president, North Campus SGA, outlined to the Board, executive, and senior administration an enumeration of student concerns on the campuses as well as college-wide issues raised by students during town halls and surveys during the term. Among the issues highlighted were access to the Fitness Center and intramural sports; more gender-neutral restrooms; access to reliable transportation and Lyft credits; more in-person evening classes; and additional food options. Senior leaders responded that all concerns were being considered in their assessments. Each presenter received updates or information on their specific concern directly from the executive leader who oversees the area or department. The SGA presentations were followed by a question-and-answer session, where students submitted video questions that were addressed by the executive leadership team.

Board Receives Details on Budget Process and Priorities Preview for the 2022-23 Financial Year

In his presentation, Caleb Cornelius, vice president, Finance, explained to the board the factors taken into consideration and the process used to develop the budget for the next fiscal year. Among them is the projected decline in enrollment from the Florida Department of Education. He indicated that while the College anticipates some decline in its full-time equivalency enrollment, it is not expected to be as steep as the projections from the state based on the model used by the Institutional Research team, under the direction of Dr. Érica Amorim, which has done extensive research and forecasts. VP Cornelius explained that the model for these enrollment projections includes Broward County High School graduation rates, the institution's retention rate, unemployment rate, COVID-19, adult population employment rate, projected job growth and current job growth, projected average earnings per job, and poverty rates. He said the model used by the College is 98 percent accurate.

VP Cornelius explained the forecast and assumptions based on various scenarios adding that while the College has aspirational goals, the fiscal plan is being developed to allocate resources where they are needed over the next few years. He shared the College's three-year working plan using all the available funding it can utilize from HEERF and the state, the budget design and development process, and the commitments to excellence in budgeting based on the priority-based funding model. He added that the operational budget priorities were faculty pay study, health insurance stabilization, and one-time merit pay for all employees.

General Counsel and Vice President of Public Policy and Government Affairs Provide Update on Legislative Session

VP Hofmeyer noted that pending final approval, the Florida College System (FCS) Council of Presidents could meet all the priorities it established for the legislative session - strengthening and bolstering the FCS program fund, renewing the FCS infrastructure, and ensuring that colleges continue to receive performance funding. Among the highlights she noted was that the legislature voted to invest an additional \$400 million in the Florida College System from Coronavirus relief funds provided by the federal government to address deferred maintenance needs. Of the \$400 million allocated to the FCS, Broward College has been allocated \$24 million. The funding will be disbursed through a submission process for each project to the Department of Education. VP Hofmeyer said if approved, this would put a significant dent in the more than \$80 million in deferred maintenance at the College. She also discussed a potential \$100 million increase to the total college system funds. VP Hofmeyer also provided a policy overview of the statutes passed during the session and how they could impact post-secondary education in the state. The budget proposals and bills are pending approval by the Governor.

Board Authorizes One-Time Payment to Part-Time Employees

At its March meeting, the Board authorized the use of existing funds for a one-time merit payment to part-time employees. The merit payment will be based on the number of hours worked.

Policy Changes

At its March 2022 meeting, the Board approved the following policy changes:

Policy 6Hx2-1.24. Board of Trustees Self-Evaluation: The policy establishes the process for the Board to conduct a self-evaluation. Each Board member will complete an evaluation survey and submit it to the Chief of Staff and Vice President of Communications and Community Relations.
