INSIGHT Into Diversity Magazine Awards Broward College the 2022 Higher Education Excellence in Diversity Award

On Tuesday, September 13, Broward College received the 2022 Higher Education Excellence in Diversity (HEED) Award from INSIGHT Into Diversity magazine, the oldest and largest diversity-focused publication in higher education. As a recipient of the annual HEED Award—a national honor recognizing U.S. colleges and universities that demonstrate an outstanding commitment to diversity and inclusion—Broward College will be featured, along with 102 other recipients, in the magazine's November 2022 issue. This is the second time the College has been honored with a HEED Award, the first award was in 2021. Broward College consistently focuses on diversity, equity, and inclusion for employees and students through initiatives, programs, and outreach. Of the more than 56,000 students served by the institution, 36.3 percent are Hispanic and 28.6 percent are Black. Of that number, 46 percent of the students are first generation college students.



U.S. News & World Report Ranks Broward College Among Top Southern Regional Colleges in 2022-23 U.S. Best Colleges List

Serving as a guide for prospective students and their families, the U.S. News & World Report Best Colleges rankings evaluate 1,500 colleges and universities on up to 17 measures of academic quality. The 2022-23 U.S. News & World Report Best Colleges listed Broward College as one of the Top Southern Regional Colleges. The College has also improved its rankings in Best Southern Regional College and Top Performer on Social Mobility Among Southern Regional Colleges. Broward College's 2022-23 rankings are as follows:

- #1 in Least Debt Acquired by Students in Southern Regional Colleges
- #12 in Top Public Schools Among Southern Regional Colleges (tie)
- #36 in Social Mobility Among Southern Regional Colleges (previously #61 in 2020 ranking)
- #54 in Best Southern Regional Colleges (previously #65-84 in 2020 ranking)

Governor Ron DeSantis Awards Broward College Grant to Expand Florida Commercial Drivers License Training

On Friday, September 16, Governor Ron DeSantis announced an expansion of Florida’s Commercial Drivers License (CDL) training. Governor DeSantis awarded \$8.2 million to five state colleges to expand the capacity of CDL training programs by at least 1,200 students per year. As part of the expansion, Broward College received \$2.6 million to lead the initiative, start a new CDL driver training program, fund tuition costs for up to 142 students, and construct a new driver training area. Broward College anticipates serving 250 students in the first year. Other institutions receiving the grant are Daytona State College, Northwest Florida State College, and Valencia College.

Hugh Adams Central Campus and was attended by approximately 125 representatives from higher education administration and faculty leadership positions from across the state who are building and implementing entrepreneurship programs at their institutions. Professor Laura McDermott Matheric was appointed the first Poet Laureate of the City of Coconut Creek. The city made the announcement on Thursday, August 25, during its monthly City Commission meeting. The appointment will span two years, beginning on September 1, 2022, and ending on August 31, 2024. In her role, Professor McDermott Matheric will promote poetry and the literary arts to all sectors of the community. She will also encourage reading existing and new poetry at civic occasions, local celebrations, and city-sponsored events at local libraries, schools, parks, and civic centers. Laura McDermott Matheric is a tenured assistant professor of English at Broward College and was the recipient of the 2014 Wells Fargo Endowed Teaching Chair.

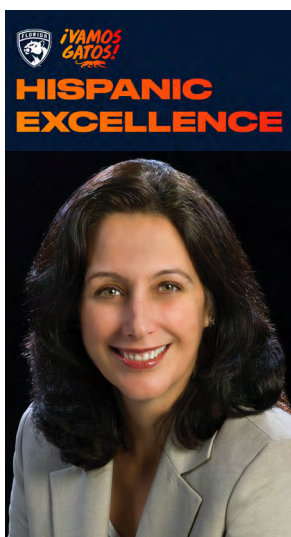

Hispanic Excellence: Standouts in Education

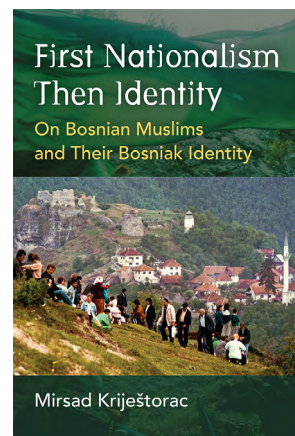

Associate Professor Dr. Mirsad Krijestorac Publishes New Book

Associate Professor of Political Science Dr. Mirsad Krijestorac published “First Nationalism Then Identity: Bosnian Muslims and their Bosniak Identity” through the University of Michigan Press on September 29. The book focuses on Bosnian Muslims, who represent a historical case of a new emerging nation. The book is among the first to be published on the topic. Dr. Krijestorac holds a Ph.D. in Political Science from Florida International University’s School of International and Public Affairs. He is also a Research Fellow at the Jaffer Center for Muslim World Studies at the Green School of International and Public Affairs. His research interest focuses on nationalism and the role of culture in politics, and he has published numerous works on these topics.

Leaders from Broward College and Partner Institutions Explore Topics of Conflict Transformation at 13th Annual Pillars Conference

Aspiring and established leaders from Broward College, including students and participants from partner institutions, convened to explore topics relating to conflict transformation at the 13th Annual Pillars Conference at The Pillars Hotel in Fort Lauderdale from Thursday, August 11 to Monday, August 15. Organized by Dr. Lulrick Balzora, dean, Social Behavioral Sciences and Human Services, the Pillars Conference is part of the Professional Enhancement Program (PEP) that provides experiences for participants to strengthen their sense of global purpose, personal well-being, and individual resilience. This year’s conference concluded a year-long program in which participants committed to reading “The Little Book of Conflict Transformation” by John Paul Lederach, which proposes that conflict transformation refers to moving from conflict-habituated systems to peace systems. Students from Broward College international partnership centers in Bolivia, Peru, and Ecuador attended this year’s conference, along with alumni from Spain, France, Panama, California, Washington, New York, and Georgia. President Haile delivered opening remarks at the conference’s evening program on Saturday, August 13, emphasizing to participants the value of conflict resolution as one of the core strengths of good leaders. Biomedical Technician Students Repair Blood Pressure Meters for Broward College Nursing Program



Students enrolled in the College's Engineering Technology program recently used their skills to help their peers in the Nursing program and gain valuable work industry experience. The students repaired medical equipment used in the Nursing program. A total of 14 blood pressure meters were fixed, including 12 mechanical and two digital meters. The repair process was a collaboration between the Industry, Manufacturing, Construction, and Transportation (IMCT) and Health Sciences pathways. Without the help of the students, the College would have spent significant funds to repair the non-functional equipment. This cross-pathway collaboration was borne out of the COVID-19 pandemic when Biomedical Technician students could not secure internships at local health care facilities. The Health Sciences programs opened their doors to these students to gain relevant experience, which also benefited Broward College. All 14 units were repaired at the North Campus Engineering Department and are now fully operational.

Broward College Foundation receives a \$93,340 investment from The Florida College System Foundation

The Broward College Foundation announced a \$93,340 scholarship investment from The Florida College System Foundation at its Board meeting on September 22. The funders for this investment include Florida Blue, Helios Education Foundation, Bank of America, and a private match from Roy and Kathryn Krause and their foundation to qualify for the full opportunity from Florida Blue. The scholarships will aid in relieving nursing and other health care professional shortages and helping first generation in college students complete their education by providing students access to high-quality, affordable academic and career educational programs. Ultimately, a trained workforce will meet Florida industry needs, and the College values the commitment of The Florida College System Foundation in ensuring Floridians have an opportunity to pursue a degree that leads to impactful careers.

Broward College Board of Trustees Vote to Authorize 2022 Florida College System Affordability Report

The Broward College Board of Trustees voted to authorize the 2022 Florida College System Affordability Report during their monthly meeting on Tuesday, September 27. Florida statute requires that each Florida College System institution submit a report on their respective college affordability initiatives, as well as a report on their textbook and materials selection process. During a presentation by Interim Vice Provost of Academic Operations, Analytics, and Communication Dr. Donald Astrab, board members were briefed on highlights from the College’s affordability measures for 2022, including a flat tuition rate for the past four years, reduced administrative fees, and the elimination of some user fees. The College also held a 95 percent average for sections posting their textbooks and instructional materials 45 days prior to the first day of class. Continuing efforts to reduce costs for instructional materials include the implementation of opt-in and opt-out provisions, digital Open Educational Resources, college-wide textbook adoptions, and the First Day Access Program, which delivers students course materials at a reduced price.

Modifications to Standardized Testing Fees Approved by Broward College Board of Trustees

Responding to an increased student demand for remote testing, the Board of Trustees voted to approve modifications to standardized testing fees associated with exam modalities from the Florida Department of Education and national professional standards organizations. Modifications to exam fees were proposed to address external remote proctoring costs of approximately \$10 per exam necessitated by the need to have external vendors to utilize specialized third-party software and varying levels of proctoring. Prior to the COVID-19 pandemic there were no remote exams offered at Broward College, and 59,911 exams were completed in person. During the 2020-21 school year, there were 11,992 remote exams completed and no in-person exams offered. During the 2021-22 school year, there were 10,379 remote exams completed and 14,519 in-person exams completed. New proposed fees for exams include a retest fee of \$30 with a remote retest fee of \$40. New proposed HESI fees include a proctoring fee of \$40 and a remote proctoring fee of \$52. Additionally, at the time of online exam registration, emphasis will be placed on the need to sufficiently prepare before taking the exam to avoid retesting. An additional message will appear on testing registration webpages to notify students of the “more affordable” in-person testing options. Broward College will make testing fees available on its website.

Broward College Board of Trustees Ratifies Year Two Agreement for the 2021-24 Collective Bargaining Agreement with Federation of Public Employees (FOPE)

The Board of Trustees voted to ratify an agreement between the College and the Federation of Public Employees (FOPE) regarding the Year Two Agreement of the 2021-24 Collective Bargaining Agreement. Modifications ratified include a \$2,000 net one-time merit payment, as well as a revised job architecture that would implement a collapsing of pay-grade levels for more competitive starting wages and retention of existing employees. This would result in an average increase of 10.7 percent and an average dollar increase of \$3,763 affecting approximately 120 employees. Also ratified was an extension of the parental leave policy to FOPE employees, consisting of 20 consecutive days for the birth, adoption, or foster care intake of an employee’s child. This would exist as an additional benefit not deducted from an employee’s accrued sick or vacation time.

In 2018, the voters of the state of Florida passed an amendment to the Constitution adding section 8(c), which states that members of the District Board of Trustees of Broward College must be residents of the service area of the College.
