#### CUPA-HR Names Broward College Winner of the National HR Excellence Award

Broward College was initially honored with CUPA-HR's Southern Regional Excellence Award and was then named the winner of the CUPA-HR National HR Excellence Award from among the four regional winners. The other regional winners were Fordham University (Eastern), Iowa State University (Midwest Region) and the University of Texas Rio Grande (Western). CUPA-HR is a college and university professional association representing more than 2,000 private and public higher education institutions across the U.S. The award follows several other recognitions received by Talent and Culture in the last year. These



awards recognize the College's efforts to improve institutional culture and retain the best and brightest talent to help fulfill its mission. Among the changes were hiring a Vice President, Talent and Culture, and the development and implementation of a Culture Transformation Plan. As part of the plan, the Human Resources department was rebranded as Talent and Culture and restructured under a new organizational chart. The restructure included the formation of a Talent Management function and the realignment of Talent and Culture business units to address the needs of the College and the areas they serve.

### Respiratory Therapy Program Recognized with Distinguished RRT Credentialing Success Award

The College's Respiratory Therapy program was recognized by the Commission on Accreditation for Respiratory Care (CoARC) as a recipient of the Distinguished Registered Respiratory Therapist (RRT) Credentialing Success Award. The award is presented as part of the CoARC's continued efforts to value the RRT credential as a standard of professional achievement. The College's full-time, two-year program offers a guaranteed internship and hands-on training with state-of-the-art equipment. The program is well-known among the local health care community for educating respiratory therapy's brightest minds for over 50 years. In selecting programs for this recognition, the CoARC Board used objective criteria based on key accreditation metrics documented in the 2021 Annual Report of Current Status. The CoARC Awards ceremony was held on Tuesday, July 26, at the JW Marriott Palm Desert Resort & Spa in Palm Springs, California.





# NAFSA Association of International Educators Awards Broward College Certificate of Export Appreciation for Partnership with the U.S. Commercial Service

The International Student Services Office (ISSO) received a Certificate of Export Appreciation from the U.S. Commercial Service at the NAFSA: Association of International Educators conference in Denver, Colorado. The recognition follows two years in which the College has actively engaged in virtual outreach opportunities with U.S. Commercial Services providing presentations to U.S. Embassy representatives in Trinidad and Tobago and Brazil. Education service exports are a critical element of the United States trade relationships, strengthening the development of the economy and attracting foreign direct investment into the U.S.



# President Haile Appointed to Board of Achieving the Dream

Achieving the Dream (ATD), a national nonprofit that is dedicated to helping more community college students, particularly low-income students and students of color, stay in school and earn a college certificate or degree, has named President Haile to its Board of Directors. In this capacity, he will continue his work toward removing barriers to higher education on a national scale. President Haile's appointment to the ATD Board is in conjunction with his current roles, which include the boards of the Federal Reserve Bank of Atlanta, Florida Chamber of Commerce, Pace Center for Girls, Everglades Foundation, Broward Workshop, United Way of Broward County, and the Greater Fort Lauderdale Alliance. President Haile is also a member of the Council on Foreign Relations. Broward College's previous partnerships with Achieving the Dream include a 2021 case study in which faculty at Broward College led efforts to fully implement and integrate adaptive courseware in introductory course design and activities.

# Students and Employees Participate in Juneteenth Celebrations

Broward College hosted its first Juneteenth cookout on Thursday, June 16, with celebrations taking place across each of the College's main campuses and online. Juneteenth (short for June 19th) is a federal holiday commemorating the day in 1865 when enslaved people in Galveston, Texas, finally learned that the United States had freed enslaved people, nearly two years after the Emancipation Proclamation was signed. It is the oldest known commemoration date for the abolition of slavery in the U.S. and was declared a federal holiday by President Joe Biden on June 17, 2021. At Broward College, festivities began at 11 a.m. with a Zoom presentation hosted by Sophia Galvin, vice president, Talent and Culture and featuring remarks by Dr. Jeffery Nasse, provost and senior vice president, Academic Affairs. There was also a historical presentation on the cultural relevance of Juneteenth by Robert Morris, professor of American History as well as a performance of "Lift Every Voice and Sing" by Tamara Bell, flutist and talent business partner. Approximately 300 people attended the in-person cookouts which included presentations, activities, musical performances, and meals from Fort Lauderdale's Tom Jenkins BBQ and other caterers.



### Broward College Hosts USCIS Naturalization Ceremony in Honor of World Refugee Day

There were 35 applicants representing 19 different countries who took the Oath of Citizenship during a United States Citizenship and Immigration Services (USCIS) naturalization ceremony on Thursday, June 16. The ceremony, which is a joint effort with the College to honor World Refugee Day, is the first to be hosted since 2019 due to the pandemic. Isabel Gonzalez, chief of staff and vice president, Communications and Community Relations, was the keynote speaker. A first-generation American and the first in her family to graduate from college, VP Gonzalez centered her remarks on the tenacity of hope through the framing of her own parents' immigration from Mexico. She reminded participants of the social, personal, and financial opportunities that being in the U.S. provided. The ceremony closed with a testimonial from Marie Tanis Occean, a refugee from Haiti who benefitted from participation in Project RENEW offered through Broward College. World Refugee Day was officially observed on June 20 and was designated by the United Nations to honor refugees around the globe.

# Research Paper by Broward College Dual-Enrollment Student Featured at Endocrine Society ENDO 2022 Conference

A Broward College Dual Enrollment student, 16 year old Maria Balhara, is making waves as one of 30 researchers whose abstracts were highlighted this year by the ENDO 2022 conference. Maria's work was featured out of 2,400 entries submitted to the Endocrine Society. Her research evaluated trends in consumption of ultra-processed foods from adolescence to young adulthood, focusing on the implications for human health. The main finding is that consumption of ultra-processed foods declined dramatically for adolescents during COVID-19. The study found that after pandemic restrictions were introduced, the average ultra-processed food consumption dropped by nearly six percent, continued to decline as COVID-19 restrictions later eased and is now almost 14 percent below the level it was before the pandemic began. She finds it noteworthy that the decline has sustained and continued even after COVID-19 restrictions have lifted.

# Police Academy and Corrections Officer Students Host Food Drive

Police Academy Classes 344 and 345, along with Corrections Officer Academy Class 172, collected an estimated 1,900 pounds of nonperishable items during a food drive on Tuesday, June 14. The donations will



support the Refugee Students Food Drive on North Campus and Harvest Drive Florida, a non-profit organization that provides food and assists families through Broward County Public Schools. The food drive reinforced the Institute of Public Safety's commitment to community service, which is a vital component of the College's cadet training.

# Spring 2021 Graduate Destine Harrison-Williams is Princeton Bound

Destine Harrison-Williams, the College's spring Commencement student speaker, has been accepted as a 2022-23 transfer scholar at Princeton University. Destine's school trajectory began as a peer mentor with the Minority Male Initiative and the Honors College.



As an academically gifted student, Destine has participated in Black Brown and College Bound and spoke at the College's first annual Juneteenth event. Hailing from rural Alabama, Destine is also a PTK-ALL USA scholar.

### Broward College Graduate Hugo Arguello, Jr. Honored with Private Graduation Ceremony at President Haile's Office

President Haile was on hand to celebrate a special graduation ceremony with graduate Hugo Arguello, Jr. on Friday, June 3, at his office at the Willis Holcombe Center in Fort Lauderdale. 

During the Board of Trustees meeting on Tuesday, June 28, organizational improvements of the Workforce Education and Innovation Department were announced with two new vice president roles introduced. Kareen Torres is now vice president, Workforce Education and Innovation, and Renée Law will now serve as vice president, Strategy, Assessment, and Research. Vice President Torres, who joined Broward College in 2014, previously served as the associate vice president of Resource Development and Sponsored Programs. Vice President Law, who joined the College in 2007, most recently served as associate vice president, Institutional Planning and Effectiveness.

#### Broward College Board of Trustees Votes to Approve the Social Enterprise Plan

The Board of Trustees approved the Social Enterprise Plan during their monthly meeting on Tuesday, June 28, endorsing the strategic framework designed to emphasize the tangible social value of the institution. The plan, when finalized, will replace the previous five-year strategic plan from 2017-2022 and is intended to engage every area of the enterprise, including faculty and other frontline staff, to achieve its aspirational goals. The project's team leaders: Renee Law, vice president, Strategy, Assessment and Research; Dr. Mildred Coyne, senior vice president, Workforce Education and Innovation; Dr. Jeffrey Nasse, provost and senior vice president, Communications and Community Relations, provided an overview on some of the



tactics to implement the plan's "big bet" aspirations to guarantee access to higher education, empower student development, and create impactful career connections. The team also indicated how it would identify initial outcomes, measurable metrics, and financial resources. With the plan now approved, the next phase will be focused on developing actions and lead measures.

# Fiscal Year 2022-23 Approved Budget Entitled Unwavering Commitment: Investing in Our Students, Our People, Our Future

On Tuesday, June 28, the Broward College District Board of Trustees passed the "Unwavering Commitment: Investing in Our Students, Our People, Our Future" budget. This budget further builds on the previous year's commitment to making investments toward enhancing the student experience and post-completion outcomes. The \$196 million seeks to balance internal and external influences such as high inflation and the nationwide decrease in enrollment being experienced across colleges. Of the \$196 million budget, the recurring amount of \$173 million includes \$96.9 million in state funding, \$67.2 million from tuition and fees, and \$8.9 million from other revenue.

Designed to integrate aspects of the College's next strategic plan, the "Unwavering



Commitment: Investing in Our Students, Our People Our Future" budget prioritizes the stabilization of student and operational investments, accelerates the expansion of operational efficiencies, and ensures care for Broward College employees. To that end, the College has allocated funding for new and continuing student success initiatives, including supplemental faculty pay, Seahawk Marketplace food pantries, BC Pride, Peer Mentoring, the Summer Seahawk Academy, and the Minority Male Initiative. The 2022-23 budget includes funding to support faculty and staff. Along with training and meaningful employee engagement opportunities, the College has also set aside \$5.15 million for a one-time retention payment for employees to help relieve the rising challenges they may face due to inflation.

# General Counsel Lacey Hofmeyer Recognized for Outstanding Leadership to Legislative Committee

General Counsel and Vice President of Public Policy and Government Affairs Lacey Hofmeyer was recognized by President Haile for her accomplishments as Legislative Committee Chair for the Association of Florida Colleges and the Legislative Chair for the local Broward College Chapter. VP Hofmeyer served in this capacity from June 2021 to June 2022, during which time the Florida College System received a historic \$400 million in deferred maintenance funds.

# Dr. Mildred Coyne Honored for Contributions as Co-Chair of Association of Florida Colleges Workforce Education Council

Dr. Mildred Coyne, senior vice president Workforce Education and Innovation, was recognized for her outstanding contribution as co-chair of the Association of Florida College's Workforce Education Council, a role she held from 2018 to 2022 and during which workforce education and innovation has taken on increasing importance in the Florida College System.
